Official Tournament Rules:

- Boat owner must carry a minimum boat liability insurance policy of \$100,000. Send copy with Registration
- High School Team must consist of two kids from the same high school and one adult boat captain over the age of 21. Proof of high school (school id or report card) and age of boat captain can be requested morning of tournament. High schoolers belonging to official B.a.s.s High School community fishing clubs do not need to belong to the same school. Junior teams may consist of two anglers, second thru eighth grade (school affiliation doesn't matter) and one adult boat captain over the age of 21.
- Adult Boat captains are prohibited from fishing. Advice, netting fish and fish care is allowed.
- 5 bass limit, 12 inches. Smallmouth and Largemouth Bass only.
- All PFBC laws are in effect, violations will result in a disqualification.
- You must be present at the awards presentation for prizes & giveaways. Boat captains will also be eligible for prizes if their team places in the top 20 overall.
- Going past boundaries will result in disqualification.
- Prizes for 2nd through 20th place based on both groups combined.

- If combustion engine is running all participants must wear a PFD including adult boat captain.
- Tournament committee has final decision on all issues.
- Tournament will be cancelled if river stage in Sunbury is forecasted to be above 13 feet.
- Bass must be kept alive in an Aerated livewell. 8 ounce penalty for dead or distressed fish weighted in. Floating fish are considered distressed
- No culling of dead or distressed fish, disqualification if rule is broken. Floating fish are considered distressed
- All competitors must stay in the boat, except for an emergency
- Artificial lures only, no trolling.
- Teams do not need to be affiliated with Pa. B.a.s.s. Nation or the PA. Bass Federation to participate.
- No competitor may be within 25ft of another competitor during competition.
- 48 hour notice must be given if you are dropping out of tournament. You will be charged a \$5.00 handling fee and \$5.00 will be returned to you via check.
- Boat captain must operate gas motor
